**PLAINTIFF ELIZABETH WILLIAMS' NOTICE OF
ACCELERATED INTERLOCUTORY APPEAL**

Please take notice that Plaintiff/Counter-Defendant Elizabeth Williams (referred to as "Plaintiff" or "Williams") hereby appeals the Court's order denying her motion to dismiss under the Texas Citizens Participation Act, Tex. Civ. Prac. & Rem. Code ch. 27, ("TCPA"). See, Tex. Civ. Prac. & Rem. Code §§§ 27.008(b), 73.051 *et seq.*, 51.014(a)(12). In support thereof—and as required by Tex. R. App. P. 25.1(d)—the following information is provided:

1. The case is styled, *Elizabeth Williams v. William Ramey, et al.*, No. 202051549 (157th Dist. Ct., Harris County, Tex. filed Aug. 25, 2020) (Garrison, J.).
2. The date of the order appealed from is March 5, 2021. Ex. A, Order on Williams' Motion to Dismiss (March 5, 2021). This Notice of Accelerated Interlocutory Appeal is filed within twenty (20) days of the date of the interlocutory order. See, Tex. R. App. P. 26.1(b).

3. Plaintiff desires to appeal the attached order granting her motion to dismiss under the TCPA without prejudice to refile as to William Ramey's claims of malicious prosecution and denying her motion to dismiss under the TCPA for the remaining claims.

4. This appeal is taken to either the First District Court of Appeals at Houston, Texas or the Fourteenth District Court of Appeals at Houston, Texas.

5. This notice is filed by Plaintiff Elizabeth Williams.

6. This is an accelerated appeal.

7. This is not a parental termination or child protection case as defined in Rule 28.4.

8. Williams has or will make arrangements to obtain and pay for both the clerk's record and the reporter's record.
