PLAINTIFF'S THIRD AMENDED DISCLOSURES UNDER FEDERAL RULE OF CIVIL PROCEDURE 26(a)

Plaintiff, County of Cook, pursuant to Federal Rule of Civil Procedure 26 (a) and based upon information presently known to Plaintiff discloses information it may rely on to support its claims against Defendants.

Plaintiff does not identify documents protected from disclosure by any applicable privilege.

Nor does Plaintiff waive the right to object to Defendants' discovery requests on any basis. Plaintiff expressly reserves the right to amend or to supplement these initial disclosures.

Plaintiff provides its initial disclosures under Federal Rule of Civil Procedure 26(a) as follows:

(i) the name and, if known, the address and telephone number of each individual likely to have discoverable information—along with the subjects of that information—that the disclosing party may use to support its claims or defenses, unless the use would be solely for impeachment;

Plaintiff may use to support its claims the Defendants' officers and directors, and compliance personnel of each Defendant entity that is likely to have discoverable information regarding liability issues, including Defendants' knowledge of, and non-compliance with their corporate policies and practices, which Plaintiff may use to support its claims, including those individuals listed on Exhibit A hereto.

Plaintiff discloses the following of offices, bureaus and departments, which may have discoverable information, and may only be contacted through counsel:

- (ii) a copy—or a description by category and location—of all documents, electronically stored information, and tangible things that the disclosing party has in its possession, custody, or control and may use to support its claims or defenses, unless the use would be solely for impeachment;

Plaintiff will disclose records used in the ordinary course of its business throughout the discovery process. All public documents referenced in the Complaint are equally available to both parties. Plaintiff will produce documents relevant to its claims including but, not limited to Board of Commissioner materials, public lien records, eviction records, court filings, costs and fees for Cook

County services, and documents maintained by the Office of the President, including the Bureau of Finance and the Bureau of Economic Development, which includes the Department of Building and Zoning, among others. Relevant documents or information will also be located within the Office of the Clerk of the Circuit Court of Cook County, Cook County Sherriff's Office, Office of the Cook County Recorder of Deeds, Cook County Chief Judge's Office, and the Cook County Assessor's Office. These separately elected officials' offices are not under the direct control of Cook County. Cook County will seek the cooperation of these offices in this litigation.

(iii) a computation of each category of damages claimed by the disclosing party—who must also make available for inspection and copying as under Rule 34 the documents or other evidentiary material, unless privileged or protected from disclosure, on which each computation is based, including materials bearing on the nature and extent of injuries suffered; and

As stated in Plaintiff's complaint, Plaintiff seeks an award of compensatory damages, punitive damages, and attorney's fees and costs. The initial estimate of damages contained in the complaints is based on the analysis of Professor William C. Apgar of Harvard University and Mark Duda in a report prepared for the Homeownership Preservation Foundation entitled *The Municipal Cost of Foreclosures: A Chicago Case Study* (see Bates 26A-0000027-0083). This analysis provides categories of damages and an estimate of a range of damages for an individual property, depending on the circumstances of each individual property. The Court's March 30, 2018 Memorandum Opinion and Order (ECF No. 204) requires that Plaintiff show a direct relationship between Defendants' conduct and the various injuries it claims it has suffered. The computation of damages requires the identification of each "subject" loans at issue in the complaint. After identification of the corresponding residential home, the County may compute the associated costs among other damages. Plaintiff has identified the following categories of damages at this time and reserves the right to supplement or otherwise amend this response after identification of additional categories of damages and the "subject" loans:

Clerk of Circuit Court, Chancery Division

Fully loaded costs associated with foreclosure case administration, including new case initiation, the issuance of summons, issuance of notices, data entry of all filing codes, creation of file jacket labels, file stamping documents, filing of physical documents in the respective file jackets, transport documents to scan, create images of all documents, transport scanned documents to file team for proper storage, and storage costs, etc.

Fully loaded costs include allocation of building space and storage space; utilities; insurance; staffing costs, including, for example, compensation, insurance, and benefits for administrators, executives, clerks, stenographers, case management personnel, data entry personnel and support staff, etc.

Office of the Chief Judge

Fully loaded costs of civil foreclosure cases, including the review of pleadings and documents, status conferences, hearings on motions, writing decisions and issuing orders, etc.

Fully loaded costs of Foreclosure Mediation Program participant mediation cases including in-court pre- and post- mediation case management and status hearings, the review of pleadings and documents, and mediations, etc.

Fully loaded costs of Foreclosure Mediation Program outreach.

Fully loaded costs of Foreclosure Mediation Program mandatory housing counseling workshops and individual housing counseling appointments, including the review of documents and report writing.

Fully loaded costs include allocation of building space and storage space; utilities; insurance; staffing costs, including, for example, compensation, insurance, and benefits for administrators, executives, and support staff, judges, and judicial staff, etc.

Sheriff's Office

Fully loaded costs of services provided relating to foreclosure cases, including enforcement of circuit court orders and evictions, etc.

Fully loaded costs of courtroom security services provided to the Office of the Chief Judge relating to foreclosure cases.

Fully loaded costs of conducting foreclosure property sales.

Fully loaded costs include allocation of building space and storage space; utilities; insurance; staffing costs, including, for example, compensation, insurance, and benefits for officers, executives, administrators and support staff, etc.

(iv) for inspection and copying as under Rule 34, any insurance agreement under which an insurance business may be liable to satisfy all or part of a possible judgment in the action or to indemnify or reimburse for payments made to satisfy the judgment.
