Justin Pfeiffer is a partner in the Houston office of Lewis Brisbois and a member of the Labor & Employment and Appellate Practices.

Mr. Pfeiffer offer clients extensive experience in litigating complex constitutional, civil rights, commercial, administrative, criminal matters in federal and state courts throughout the country. He has successfully argued at two different courts of appeal and at state courts of last resort. Mr. Pfeiffer have appeared in the Supreme Court of the United States as counsel of record on three separate occasions, the United States Court of Appeals for the Fifth Circuit as counsel of record seven times, including on behalf of seven million people, the Supreme Court of Texas twice, and once in the Texas Court of Criminal Appeals where he represented 42% of the population of Texas.

In the Texas Court of Criminal Appeals, Mr. Pfeiffer argued on behalf of Texas's urban county prosecutors addressing the important issue of first impression of whether the Constitution of Texas allows the Legislature to provide the Attorney General with independent authority to initiate criminal prosecutions. He asserted that the framers of the Texas Constitution provided the Attorney General with broad civil grants of authority, but intentionally fragmented and decentralized prosecutorial authority in line with prevailing Jacksonian ethos of that time. This matter is particularly important because the new Texas voting statutes largely rely on criminal enforcement provisions. There, Mr. Pfeiffer represented Brian M. Middleton, District Attorney of Fort Bend County (268th Judicial District of Texas), Joe D. Gonzales, Criminal District Attorney of Bexar County; Kimbra Kathryn "Kim" Ogg, District Attorney of Harris County; John Coleman Creuzot, Criminal District Attorney of Dallas County; Mark A. González, District Attorney of Nueces County (105th Judicial District); José Pompa Garza, District Attorney of Travis County (53rd Judicial District); and Delia Aileen Garza, County Attorney of Travis County).

After graduating Order of the Coif from Michigan Law School, Mr. Pfeiffer began his legal career as a law clerk to Judge William B. Shubb of the Eastern District of California in Sacramento, California. Immediately thereafter, he served as a law clerk to Judge Priscilla R. Owen of the Fifth Circuit in Austin, Texas. He received by B.A. from the University of Virginia where he was elected to Phi Beta Kappa and finished in the top 1% of his class.

Mr. Pfeiffer's substantive federal experience includes the following areas of law: securities, constitutional, civil rights, environmental and land use, administrative, patent, copyright, federal criminal, federal death penalty, habeas and death penalty, employment, immigration, bankruptcy, and civil and criminal procedure. As evidenced by his published opinions, he am a leading expert on the Constitution of Texas.

In private practice, Mr. Pfeiffer served as lead counsel for Bela and Marta Karloyi in the California Nassar Cases, securing a dismissal of the causes of actions against them and their entities. Mr. Pfeiffer has represented a major mutual fund provider against class actions alleging claims under federal securities law and state law. He helped achieve dismissal of the state-law claims and substantially limited the federal claims. He helped achieve an interlocutory reversal, pursuant to 28 U.S.C. § 1292(b), of the district court's conclusion that a federal securities statute provided a private right of action thereby saving the client from discovery.

Mr. Pfeiffer am bilingual in Castilian Spanish. He attended the University of Salamanca between undergraduate and law school where he completed coursework with native Spaniards and other students Latin America.

Mr. Pfeiffer have extensive connections throughout Spanish-speaking world and have been decorated by foreign governments for merit.
