#### **DEFINITIONS**

"You" and "Your" means Quinwood Coal Sales LLC, and/or the person or entity to whom this subpoena and document requests are propounded and includes any insureds, agents, employees, members, representatives, predecessors, attorney(s), or any other individual or entity presently or formerly acting on the behalf or at the request of said party.

"Party" means any person and/or entity that is a party to this lawsuit.

"Plaintiff" and "Defendant" have their ordinary meaning in the context and include, where applicable, officers, directors, employees, agents, partners, corporate parents(s), subsidiaries, and/or other affiliates. This definition is not intended to impose a discovery obligation on any person who is not a party to the litigation.

"Person" means any natural or juridical individual, entity, or association.

"Document" means every writing or other source of recorded information of whatever nature and by whatever means recorded and whether claimed to be privileged or otherwise excludable from discovery including, but not limited to, the following: written memoranda, notes, records, interoffice communications, telegrams, letters, correspondence, reports, minutes, diaries, books, manuscripts, charts, graphs, drawings, galley proofs, photographs, videotapes, electronic mail, faxes, phono-records, recordings (tape, disc or others), other compilations of data from which information can be obtained, microfilm, computer printouts or documents obtainable from electronic data storage equipment, summaries of personal conversations, invoices, specifications, shipping papers, sketches, blueprints, reports of tests, photocopies and any and all other papers and writings, including drafts, originals and copies.
