COMES NOW, Plaintiff, Specialty Metal Products, Inc. d/b/a SMP Supply, ("Plaintiff" or "SMP"), and files this Motion to Dissolve the Post-Judgment Writ of Garnishment and Dismiss Zions Bancorporation d/b/a Amegy Bank NA ("Garnishee") without prejudice. In support thereof, Plaintiff respectfully shows the Court the following:

Plaintiff recovered a judgment against Innovative Heat Treatment Solutions, Inc. ("Debtor"), on the 18th day of May, 2022 for the sum of \$83,731.62 in the 157th Judicial District of Harris County, Texas, in a cause numbered 2022-04484 and styled *Specialty Metal Products, Inc. d/b/a SMP Supply v. Innovative Heat Treatment Solutions, Inc.* (the "Underlying Lawsuit").
