Plaintiff filed its Original Petition and Application for Temporary Restraining Order, Temporary Injunction, and Permanent Injunction on October 20, 2022. On October 21, 2022, Ancillary Judge Ursula Hall entered a Temporary Restraining Order, which Order set the hearing on Plaintiff's Application for Temporary Injunction for October 31, 2022, at 3:00 p.m. Defendant Joseph Jackson attended the ancillary hearing and conferred with Judge Hall prior to entry of the Temporary Restraining Order.



p.m., and that the Temporary Restraining Order be extended until that date or until the hearing on Plaintiff's Application for Temporary Injunction, whichever occurs later, in order to preserve the status quo until the Court can consider the request for Temporary Injunction.


