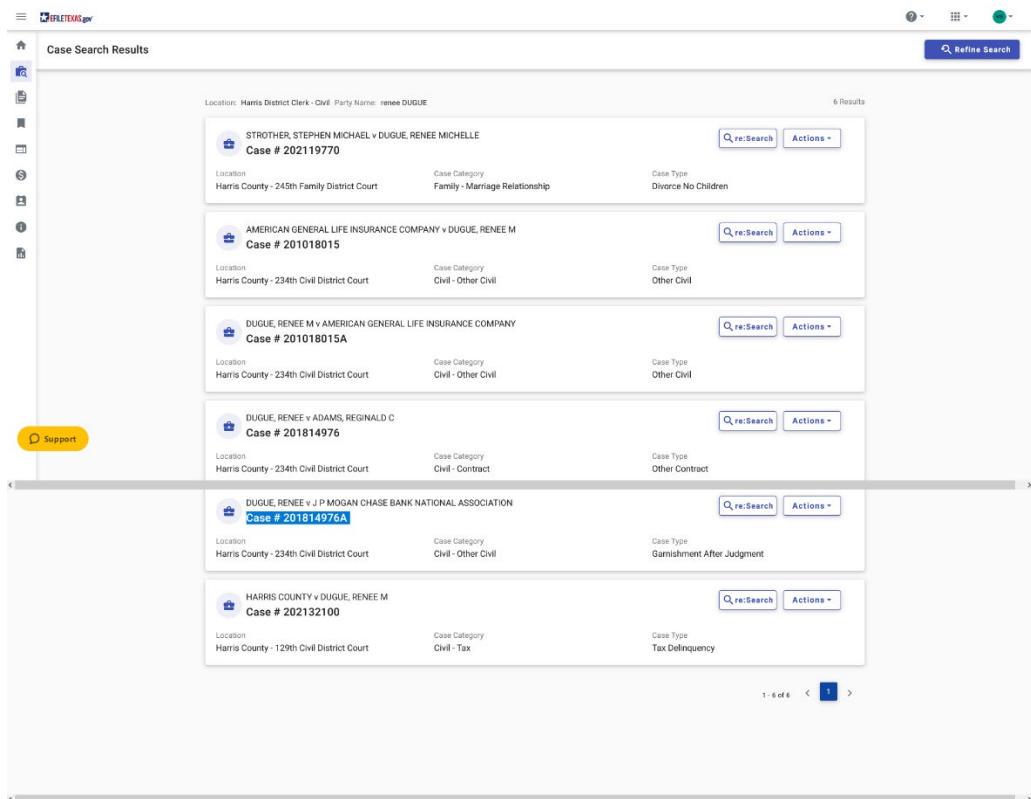
The Correct Case No. For the Motion to Intervene and Proposed Order

The above filings were correctly labeled by Intervenor as to Case # 202259087, (“2022”) and styled per the Court; DUGUE, RENEE vs. J. P. MORGAN CHASE BANK, NATIONAL ASSOCIATION, which is Court 127, Judge Ravi Sandill presiding.

The Unusual Circumstances May Have Confused the Clerks When Approving the Filings

The filings, namely the Motion to Intervene and Proposed Order should be filed in the 2022 case as shown above. The reason Intervenor filed into the 2018 case is because he could not file into the 2022 case, which is

sealed in its entirety. As such, when Intervenor was on the e-file portal EFILETEXAS.gov, the 2022 case does not appear, see screenshot below;



E-filing is Mandatory

This Court mandates e-filing only, so the Intervenor filed into the related case, the 2018 Garnishment After Judgment case. See; screenshot below from Judge Schaffer's Court explaining e-filing only;
