TEMPORARY RESTRAINING ORDER AND ORDER SETTING HEARING FOR **TEMPORARY INJUNCTION**

The Court finds that Defendant US Bank will commit said act on February 7, 2023 before notice of a hearing on the Application for Temporary Injunction can be served and hearing had; and that if the commission of said acts be not immediately restrained, Plaintiff will suffer immediate and irreparable injury, to-wit: Plaintiff will suffer wrongful interference with possession and ownership of unique real property.
