**MOTION TO SUBSTITUTE COUNSEL**


Plaintiff Jonathan Anderson files this Motion to Substitute Counsel. Plaintiff shows:


Minerve as Counsel of Record for Plaintiff. Plaintiff further requests such other and further relief to which he may be entitled.
