
Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **LYNDELL LEROY PRICE** hereafter styled the Defendant, heretofore on or about **NOVEMBER 19, 2013**, did then and there unlawfully intentionally and knowingly cause bodily injury to **CANDACE CLEMENT**, hereafter styled the Complainant, a PERSON WITH WHOM THE DEFENDANT HAD A DATING RELATIONSHIP, by impeding the normal breathing and circulation of the blood of the Complainant by **APPLYING PRESSURE TO THE COMPLAINANT'S NECK**.


**PROBABLE CAUSE**

Affiant Bartlett, Charles is a peace officer the Houston police department. Affiant has reason to believe and does believe Price, Lyndell hereafter called the defendant, committed the offense of Assault impeding breathing family violence in Harris County, Texas on or about November 19, 2013 at 4709 Dowling St. Houston TX 77004 in. Defendant Price intentionally and knowingly assaulted complainant Clement, Candace hereafter styled the complainant by strangulation and inflicting bodily injury.  
Affiant basis his beliefs on the following facts. Affiant conducted a follow up investigation and began by reviewing officer E.A. Cruz's offense report 145298013J and complainant Clement's sworn statement. Affiant believe complainant to be a credible and reliable person. Complainant stated that defendant Price assaulted her and she knows him by name and sight as her ex-boyfriend. Complainant stated that she and the defendant had got an apartment together. Complainant stated that she became pregnant with the defendant's child at which point he urged her to get an abortion. Complainant stated she found her own apartment and let the defendant stay in the one they had together. Complainant stated that on November 19, 2013 she was at a night club located at 4709 Dowling St. Houston TX 77004, in Harris County Texas and she saw the defendant there. Complainant stated that she approached the defendant about some unpaid bills at which time he became angry and pushed her out of his way. The complainant stated that she spilled a cup of water on the defendant due to him pushing her. Complainant stated the defendant called her a bitch and then grabbed her by the neck and slammed her head into the concrete floor causing her to feel pain. Complainant stated that it took five or six people from the club to get him off her. Complainant stated the defendant broke through the crowd and grabbed her by the neck a second time causing her to be unable to breath and again took several people to get the defendant off her. Affiant reviewed pictures that the complainant took of her injuries. Affiant observed the photos to show redness on the chest and lower neck and petechial hemorrhaging in her right eye.
