- 8. This petition was filed to stop the foreclosure scheduled for May 2, 2023 as I did not receive any notice of the foreclosure and I filed due to usury based upon fees and interest charged on the loan.

MOTION TO SET HEARING FOR TEMPORARY INJUNCTION

- 9. I would like to set my Petition requesting a temporary injunction for hearing so as to stop any foreclosure proceedings during the pendency of this lawsuit.
- payments and mortgage statements with the same and consistent amount owed under the terms of the deed of trust. Plaintiff has made payments on the mortgage loan as required, but then the Defendant did increase the interest on the loan in violation of the Deed of Trust. The interest rate went from 12% to 14% in November 2022. The increase in the interest rate caused the Plaintiffs to fall behind in the mortgage payments.
