Whereas in the 11th District Court, of Harris County, Texas, in Cause Number 2022-23850, was ASSOCIATED ENERGY GROUP LLC Plaintiff, and GOLDEN STATE JET LLC was Defendant. The Plaintiff, on JANUARY 30, 2023 secured a Judgment against said GOLDEN STATE JET LLC Defendant in the amount of \$41,349.63 dollars plus \$3,101.59 interest through AUGUST 22, 2022, with interest accruing at the rate of \$13.49 per day through the date of judgment. Interest continues to accrue at the rate of 18% post-judgment. In additional, the court awarded AEG attorneys' fees in the amount of \$5,000 through the trial of the matter with additional attorneys' fees of \$25,000.00 in the event an appeal is made to the Court of Appeals but is unsuccessful and additional attorneys' fees of \$25,000.00 in the event an appeal is made to the Texas Supreme Court but its unsuccessful. - 1. What effects, if any of the said defendant you had in your possession, and had when this writ was served.
- 2. What other persons, if any, within your knowledge, are indebted to the said defendant, or have effects belonging to Said defendant in their possession.

YOU ARE FURTHER COMMANDED not to pay to defendant any debt or to deliver to him any effects pending further order of this court.

### TO DEFENDANTS: GOLDEN STATE JET LLC

Your money or property has been frozen or seized ("garnished") because WELLS FARGO BANK NA (the "Garnishor") has filed a garnishment proceeding.
