## **PROPOSED FINAL JUDGMENT**

BEFORE THIS COURT, on August 2, 2023, Defendant and Counter-Plaintiff HCA Houston Healthcare Kingwood ("Defendant") filed its Notice of Nonsuit as to all of its remaining claims against Plaintiff and Counter-Defendant Mark Burke ("Plaintiff"). On July 20, 2023, the Court previously issued an order dismissing all of Plaintiff's claims including his claims against Defendant and its attorneys, Nicole Andrews, Benjamin Hamel, and Madison Addicks ("attorneys"). As included therein, the Court also awarded Defendant and its attorneys their reasonable and necessary attorneys' fees and sanctioned Plaintiff in the form of monetary relief. All claims now being finally resolved the Court now renders judgment as follows:

It is hereby, ORDERED, ADJUDGED, AND DECREED that Defendant and its attorneys shall recover from and against Plaintiff their reasonable and necessary attorneys' fees in the amount of \$4,079.50. It is further,

ORDERED, ADJUDGED, AND DECREED that Defendant and its attorneys shall recover from and against Plaintiff sanctions in the amount of \$500. It is further,

ORDER, ADJUDGED, AND DECREED that all payments ordered above shall be paid by sending payment to Defendant's attorneys Serpe Andrews, PLLC, America Tower, 2929 Allen

Parkway, Suite 1600, Houston, Texas 77019 within thirty (30) days of the entry of this final judgment. It is further,

ORDERED, ADJUDGED, AND DECREED that Defendant and its attorneys conditionally shall recover from and against Plaintiff their reasonable and necessary appellate attorneys' fees and costs of court, in the event this judgment is appealed unsuccessfully, the amount of such fees to be determined after the conclusion of any and all appeals. It is further,

ORDERED, ADJUDGED, AND DECREED that Defendant and its attorneys shall recover from and against Plaintiff reasonable and necessary attorneys' fees incurred for enforcement and collection of this Judgment. It is further,

ORDERED, ADJUDGED, AND DECREED that all writs and processes for the enforcement and collection of this Judgment or the costs of court may issue as necessary and when appropriate.

Any other requests for relief not expressly granted herein are DENIED. This Judgment is final, disposes of all claims and parties, and is appealable.
