ORDERED, ADJUDGED AND DECREED that the Defendant's Motion for Summary Judgment and No-Evidence Motion for Summary Judgment be and the same is hereby GRANTED.

It is therefore ORDERED, ADJUDGED AND DECREED that the Plaintiff, David Soliz, shall have and take nothing of and against the Defendants, J and B Hicks, Inc., dba Eastex Collision Repairs, and US 69 Enterprise LLC and Delores Hicks/individual, and J and B Hicks Inc. dba US 59 Enterprise, Jerry Hicks/individual, Dustin Dietert/individual. All claims of the Plaintiff against the Defendants are dismissed with prejudice.

It is further ORDERED, ADJUDGED AND DECREED that the Defendant, J and B Hicks, Inc. dba Eastex Collision Repairs and dba US 59 Enterprise is awarded judgment against David Soliz in the amount of \$20,490.00 with interest on such amount at the rate of ~~7.75%~~<sup>5.5%</sup> per annum on this amount from date of judgment until paid and, in the event of an unsuccessful appeal by David Soliz with the Court of Appeals, that J and B Hicks, Inc. dba Eastex Collision Repairs and dba US 59 Enterprise is awarded judgment against David Soliz in the amount of \$25,000.00 plus interest at the rate of ~~7.75%~~<sup>5.5%</sup> per annum as the reasonable and necessary attorney's fees in connection with such an

an appeal; that J and B Hicks, Inc. dba Eastex Collision Repairs and dba US 59 Enterprise shall recover all costs of Court against David Soliz for all of which let execution issue.

J and B Hicks, Inc. dba Eastex Collision Repairs and dba US 59 Enterprise is awarded all writs and processes as may be necessary in order to effect collection of this judgment.

This judgment disposes of all parties and all claims and is appealable. All of the relief not expressly granted is DENIED.
