Since he began his practice in 1981, Bill has developed considerable experience in several essential areas of commercial, mineral, environmental and mass tort litigation. His practice in both federal and state courts has involved the quality management of complicated litigation to positive conclusions. For example, over a period of several years, Bill played a leading role in securing a no liability jury verdict defending a local industry against the claims of more than 1700 plaintiffs, who were asking the jury to award more than a billion dollars in actual and punitive damages. That major verdict was listed by the National Law Journal in its May 22, 2000 publication, among the top 15 "major civil-suit verdicts that beat the odds." In addition to his regular practice, Bill served for 14 years as the Firm's Managing Partner, through the end of 2015. He is enjoying resumption of his full-time, very gratifying practice on client work.


Here are more recent examples of the variety of significant litigated matters Bill has had the privilege of handling. In 2013, Bill secured a complete dismissal of a >\$2 million attorney malpractice claim, based on the former client being estopped from complaining about a joint defense at trial, which the client originally approved, hired its own independent lawyers to monitor the proceedings, then criticized after it did not like the result. In 2015, Bill secured a forced buyout at a reasonable price, for minority shareholders in a family held corporation, who had grounds to establish that the controlling owners were acting in bad faith to oppress the minority shareholders. The buyout was secured to avoid a trial that would have been the first trial of such issues, in either state or federal court, under the new Louisiana Business Corporation Act, created by Act No. 328, effective January 1, 2015. In 2016, Bill completed many years of work on getting a complicated lawsuit dismissed, in which 360 claimants sued in 2003, claiming damages from the remnants of a 1983 railcar spill. All 360 claims were ultimately dismissed, by dispositive motions, based on the pertinent statute of limitations and/or the absence of any proven completed pathways of exposure. To secure that result, it was necessary to obtain reversals of earlier decisions in the case, based on all the additional evidence and expert opinions developed as to the lack of any merit to the claims. A key element was the extent to which the plaintiffs' experts' opinions were impeached, as inconsistent with their own work on other cases.

In 2017, Bill secured a confidential settlement for the owners of valuable land supporting docks on the Calcasieu Ship Channel, after getting the trial court and Court of Appeal to reject arguments by a tenant that it could not be held liable for unfair trade practices arising from its deceptive conduct, concealing years of neglecting the docks, in an effort to avoid or postpone time sensitive dock and bulkhead repairs. In 2020, based on the results of a twenty-day federal court trial, with Bill serving as trial counsel for plaintiff, the client secured a \$124.5 million judgment, finalized in 2022. Bill was born in Lake Charles on December 28, 1957. He was valedictorian of the 1975 Class of Lake Charles High School [as were his mother, Mary Ann Maxfield Monk, and three sisters]. He attended LSU as an Alumni Top 100 Scholarship recipient, where he received an undergraduate degree in History in 1978, and his Juris Doctorate in 1981. Bill and his wife, Aimee Judice Monk, have five children. He is a member of the Immaculate Conception Cathedral Church, and his recreational interests include golf, hunting and music.
