The Note is secured by a first and superior vendor's lien and superior title retained in this deed in favor of the Lender, and by a deed of trust of the same date from the Grantee to **ALLAN B POLUNSKY**, Trustee for the benefit of the Lender.

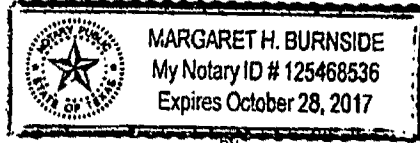
