PLAINTIFF’S NOTICE OF DISMISSAL OF JOANNA BURKE WITHOUT PREJUDICE

Pursuant to Tex. R. Civ. P. 162, Robert J. Kruckemeyer (“Kruckemeyer”) files his Notice of Dismissal of Joanna Burke Without Prejudice as follows:

The first full paragraph on page 8 of the Defendants Mark Burke & Joanna Burke’s Original Counterclaim and Application for Permanent Injunction (“Counterclaim”) reads, in part, as follows: “Mark [Burke], as editor is responsible for these posts, and as such admits to his role and position as the sole director of Blogger Inc.”

As Mark Burke has judicially admitted that Mark Burke is responsible for the posts on Blogger Inc. it is no longer necessary to pursue claims against Joanna Burke.

Accordingly, Kruckemeyer dismisses his claims against Joanna Burke without prejudice to his right to refile the same claims.
