The loan was in 2016, a letter\* demanding payment of the defaulted personal loan was issued by another law firm in 2018 and when that failed, passed to the unbonded Bandit debt collectin' law firm of Kruckemeyer to collect.

\*There's a dispute over debtors name, is it John Harvey Slocum or John Henry Slocum?

Whilst it's clear from our investigation that Elzner and Slocum were at one point business partners and that relationship has obviously soured, the loan paperwork and debt collection letter clearly confirms this is a personal loan between the two individuals.
