MOTION TO COMPEL AND FOR SANCTIONS**

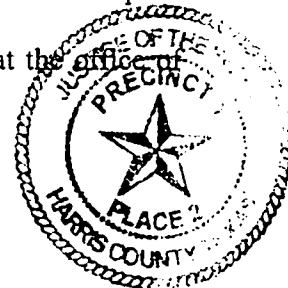

The Court finds that Defendant was properly served with post judgment discovery and with Plaintiff's Motion to Compel and For Sanctions and with notice of this hearing, and that good cause exists for the Motion be granted as follows:

IT IS ORDERED, ADJUDGED AND DECREED that Plaintiff's Motion to Compel and for Sanctions for Failure to Respond to Post Judgment Discovery be, and hereby is, granted. IT IS ORDERED, ADJUDGED AND DECREED that Christopher Gavin Middleton, shall answer Plaintiff's First Set of Interrogatories in Aid of Judgment and Plaintiff's Request for Production in Aid of Judgment without objection within 30 days after service on Defendant of a copy of this Order.

IT IS ORDERED, ADJUDGED AND DECREED that Christopher Gavin Middleton pay to the order of "Bluebonnet Financial Assets", Plaintiff, the amount of \$725.00, as attorney's fees and expenses for bringing this motion, within 30 days after service on Defendant of a copy of this Order.

IT IS ORDERED, ADJUDGED AND DECREED that Christopher Gavin Middleton shall serve the answers to Plaintiff's First Set of Interrogatories in Aid of Judgment and Plaintiff's Request for Production in Aid of Judgment, and shall pay the above amount of money, at the office of

REQUEST FOR ADMISSIONS

1. Admit that you received a copy of the judgment in the cause.
2. Admit that the judgment against you in this cause is subsisting, valid and unpaid.
3. Admit that Plaintiff has offered you a chance to make payments on the judgment amount.
4. Admit that you have not contacted Plaintiff or the court with any change of address or phone number.
5. Admit that you currently have a bank account.
6. Admit that you own and have, or will have, within your possession or control, property, which is not exempt from attachment, execution, or any other type of seizure for the satisfaction of the judgment in this cause.
7. Admit that Plaintiff has complied with all laws concerning the collection of the debt which was at issue in this cause.
8. Admit that the property of the Defendant which is subject to collection, and not exempt therefrom, includes, all of your right, title, and interest to any property whether held individually or held jointly with another person.
9. Admit that the court is within its discretion to issue a writ of garnishment against you to enforce collection of the judgment in this cause.
10. Admit that the court is within its discretion to sign an order of sale of your property to satisfy the judgment in this cause.
11. Admit that the court is within its discretion to sign an order granting turnover and appointing a master in chancery and appointing a receiver to satisfy the judgment in this cause.
12. Admit that the court is within its discretion to issue a writ of execution against you to enforce collection of the judgment in this cause.
13. Admit that the property of the Defendant which is subject to collection, and not exempt therefrom, includes, all of your right, title, and interest to all notes payable to the order of Defendant.
14. Admit that you own and have, or will have, within your possession or control, property, which cannot be readily attached or levied on by ordinary legal process.



15. Admit that the property of the Defendant which is subject to collection, which is not exempt as homestead and which is not exempt under any other exemption, includes all of your right, title, and interest to the real property commonly known as 4715 Bayou Vista Dr, Houston, TX 77091-4503.

22. Admit that the property of the Defendant which is subject to collection, and not exempt therefrom, includes, all of your right, title, and interest to all partnership interests.

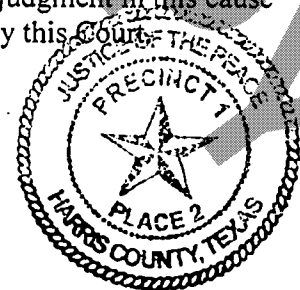
