
CAUSE NO. 2022-11380

ORDERED that the Motion on Plaintiff's Negligence Claim against Defendant David Taylor is GRANTED. It is further,

ORDERED that the Motion on Plantiff's Civil Conspiracy Claims against Defendants Whitestone REIT, David Taylor, Jack Mahaffey, Jeff Jones, Nandita Berry, David Holeman, Christine Mastandrea and Peter Tropoli is GRANTED. It is further,

ORDERED that the Motion on Plaintiff's request for attorneys' fees is GRANTED. As a matter of law, Plaintiff is not entitled to attorneys' fees for a claim of tortious interference with contract or a claim of negligence. Likewise, Plaintiff's Employment Agreement with Whitestone forecloses attorneys' fees for suit related to the Employment Agreement. It is further,

ORDERED that the above claims be, and are hereby, DISMISSED WITH PREJUDICE, each party to bear its own costs.
