On this date the Court considered the Tex R Civ P 736 Home Equity Foreclosure Application of DEUTSCHE BANK NATIONAL TRUST COMPANY, AS TRUSTEE FOR THE REGISTERED HOLDERS OF MORGAN STANKEY ABS CAPITAL I INC. TRUST 2007-HE7 MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2007-HE7, or their successors or assigns (hereinafter "Petitioner").
