6. The total amount due and owing to the Lien Claimant is \$1,750.00. This amount is just, due, and correct, after allowing all just credits, offsets, and payments. The

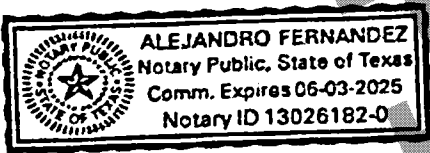

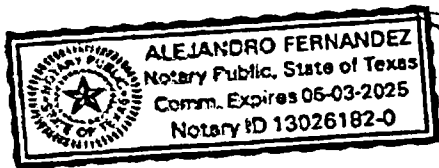
