No. 04-19-00416-CV and Tr. Ct. No. 2013-CI-19561

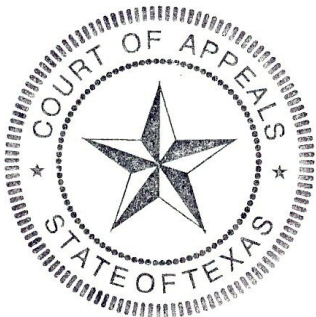
was determined, and therein our said Court of Appeals made its order in these words:

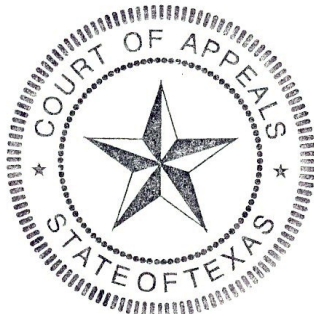
