I will and direct that at the time of my death that all of my just debts including funeral expenses and expenses of my last illness be paid by my Executor hereinafter appointed, as soon after my death as can be conveniently done without the unnecessary sacrifice of any of the properties of my estate.

I hereby nominate and appoint FELICIA OLIVER, as Independent Executor of this my Will and Estate to act without bond and free from supervision of any Court.
