SUGGESTION OF BANKRUPTCY

Please be advised that Addison Oaks Holdings, LLC filed a voluntary petition under Chapter 11 of Title 11 of the United States Bankruptcy Code and was assigned the following Case number 24-80128 pending in the United States Bankruptcy Court for the Southern District of Texas, Galveston Division.

The filing of a voluntary petition operates as an automatic stay, applicable to all entities, of among other things: (a) the commencement or continuation of all judicial, administrative, or other actions or proceedings against the Debtor (i) that were or could have been commenced before the commencement of the Debtor's bankruptcy case or (ii) to recover any claims against the Debtor that arose before the commencement of the Debtor's bankruptcy case; (b) the enforcement against the Debtor's or against any property of the Debtor's bankruptcy estate, of a judgment obtained before the commencement of the Debtor's case; of (c) any act to obtain possession of the property of or from the Debtor's bankruptcy estate, or to exercise control over property of the Debtor's bankruptcy estate. See 11 U.S.C § 362.

Wherefore, Addison Oaks Holdings, LLC, a Defendant herein, hereby advises the Court of the pending Chapter 11 bankruptcy proceeding, and that Addison Oaks Holdings, LLC be granted such other and further relief to which they may be justly entitled.
