ORDER TO PROCEED WITH REAL PROPERTY FORECLOSURE SALE UNDER TEXAS RULE OF CIVIL PROCEDURE 736

On this day, the Court considered applicant, U.S. BANK TRUST NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACTS BUT SOLELY AS OWNER TRUSTEE FOR RCAF ACQUISITION TRUST, *Application under Texas Rule of Civil Procedure 736 Seeking an Order to Proceed with Foreclosure* seeking a Tex. Const. Art. XVI § 50*a*(6)(D) order of foreclosure of a home equity foan created pursuant to Tex. Const. Art. XVI § 50*a*(6).
