Additionally, RASHIDA MOSI OVERBY, did then and there e-file civil pleadings, with the intent to simulate legal process, including, but not limited to, actions affecting title to real estate or personal property, indictments, subpoenas, warrants, injunctions, liens, orders, judgments, or any legal documents or proceedings, knowing or having reason to know the contents of any such documents or proceedings or the basis for any action to be fraudulent, to wit: persons, in the properties described in the instruments. RASHIDA MOSI OVERBY, did then and there, willfully and without authorization, fraudulently use, or possess with intent to fraudulently use, personal identification information, concerning a person, to-wit: e-filed pleadings in a civil case, concerning numerous victims without first obtaining their consent on Broward County Clerk of the Court civil cases.

Your Affiant began an investigation into the activities of Illya and Patricia Tinker's company identified as GLOBAL MANAGEMENT CONSULTING GROUP CORP/GLOBAL HOME BUYERS, in June of 2016, regarding running a large-scale, sophisticated, fraudulent takeover of residential properties throughout Broward County by filing false/forged documents in the Broward County Official Records, mainly targeting deceased homeowners.

RASHIDA MOSI OVERBY has been licensed to practice law in the State of Florida since April 20th, 2001, Florida Bar # 474230.

A further records search through SunBiz.org, the Florida Department of State Corporations database, hereinafter "SunBiz," yielded that RASHIDA MOSI OVERBY /Overby Law LLC/4942 N. University Dr., Lauderhill, FL 33351, was the Registered Agent for
