Rashida Overby has been licensed to practice law in the State of Florida since April 20th, 2001, Florida Bar # 474230. A further records search through SunBiz.org, the Florida Department of State Corporations database, hereinafter "SunBiz," yielded that Rashida Overby /Overby Law LLC/4942 N. University Dr., Lauderhill, FL 33351, was the Registered Agent for Global Management Consulting Group in 2017 continuing through 2019. Rashida Overby was added as the registered agent in a document filed November 8, 2017. She continued to be the registered agent until June 3, 2019, when a Resignation of Registered Agent was filed. Also through SunBiz, Rashida Overby /Overby Law, LLC/8747 NW 50th Street, Lauderhill, Florida 33351, was the registered agent for Global Homebuyers LLC in beginning on April 23, 2018 and continuing through the most recent filing of March 6, 2019. This document was provided to the Florida Bar by Attorney Ria Balram regarding the foreclosure surplus check of \$78,131.94 from the Broward County Clerk of the Court. This document was determined to be fraudulent for the reasons stated below. This Affiant then contacted Detective Scott Tobin from the Denville Police Department, New Jersey, on September 4th, 2020, to respond out to the residence of victim Carole Sachs, owner of these surplus funds stolen by Attorney RIA SANKAR-BALRAM through a fraudulent pleading to Judge Michael Robinson. Carole Sachs, provided a sworn video statement to Detective Tobin, declaring that she did not sign this document, does not know Attorney's RIA SANKAR-BALRAM or Rashida Overby, nor the owner of G.E.R.S, and never received any of the monies owed to her. Detective Tobin also viewed signatures that Carole Sachs provided to him and advised that her signature was different than the signature on the document in question. It should be noted that the address for Carole Sachs on this pleading was not her home address, and was notarized by New Jersey Notary Karen L. Gordon, purportedly on January 26th, 2019. Also noted on this document was that it was checked off by the notary, "was produced identification - State DL", but no number was inputted.
