PLAINTIFF'S MOTION FOR SUBSTITUTE SERVICE OF PROCESS

Plaintiff, Nationstar Mortgage LLC, ("Nationstar") asks the court to authorize service of process on Defendant, Excess Funds Online, LLC ("Excess Funds") pursuant to Tex R. Civ. Proc. 106(b) by delivering process to its registered agent Anthon Welch in the manner requested. In support, Nationstar shows the following.

1. Excess Fund's registered agent Anthony Wetch's, whose address for service of process is 18814 Cove Vista Lane, Cypress TX 77433.

2. Nationstar attempted personal service on but failed to personally serve Excess Funds through its agent at the address for service specified by the Texas Secretary of State on three or more occasions. These service attempts and the facts appurtenant thereto are set forth in the affidavit of service attached hereto as Exhibit 1.

3. The Affidavit of Plaintiff's process server establishes facts not apparent from the record. The affidavit provides proof of the reasonableness of Nationstar's attempts and that the alternative service requested will be sufficient to provide Excess Funds notice of the suit.

4. Nationstar asks the court to sign an order authorizing Nationstar to serve Defendant, Excess Funds' registered Agent Anthony Welch by any one of the following methods:

a. By Delivering a true copy of the Citation and Petition and Order authorizing substituted service attached, with anyone more than sixteen (16) years of age 18814 Cove Vista Lane, Cypress, TX 77433; or

- b. By attaching a true copy of the Citation and Petition and Order authorizing substitute service, securely to the front door or entry way at 18814 Cove Vista Lane, Cypress, TX 77433, and if the property is protected by a fence, by attaching securely to the gate at 18814 Cove Vista Lane, Cypress, TX 77433.
- 5. Nationstar asserts to the Court that based on the evidence attached, the manner of service

requested and ordered will be reasonably effective to give said Defendant notice of the lawsuit.

WHEREFORE, PREMISES CONSIDERED, Nationstar requests that the court grants its

motion, and enter an order providing for substituted service on Excess Funds as requested herein.
