SUGGESTION OF BANKRUPTCY AND NOTICE OF AUTOMATIC STAY

Defendants/Counter-Plaintiffs/Third-Party Plaintiffs Defendants HSBC Bank USA, National Association, as Trustee for ACE Securities Corp. Home Equity Loan Trust, Series 2003-OP1 ("<u>HSBC as Trustee</u>") and PHH Mortgage Corporation ("<u>PHH</u>") (collectively, "<u>Counter-</u> <u>Plaintiffs</u>") file this Suggestion of Bankruptcy of Third-Party Defendant Sandra Nicely Falconer ("<u>Falconer</u>") and Notice of Automatic Stay and state as follows:

Plaintiff Capital Fund I, LLC ("<u>Plaintiff</u>") filed an Amended Complaint on September 26, 2024.¹ Counter-Plaintiffs filed an Original Counterclaim against Plaintiff and a Third-Party Complaint against Falconer and Remus Nembhard ("<u>Nembhard</u>") (the "<u>Third-Party Complaint</u>") on October 29, 2024.² Falconer and Nembhard were served with copies of the summons, the Third-Party Complaint, and the Scheduling/Docket Control Order in this case on November 1, 2024.³ Falconer and Nembhard's deadline to answer the Third-Party Complaint was on November 27, 2024. *See* FED. R. CIV. P. (a). Neither Falconer nor Nembhard filed an answer.

On December 3, 2024, Falconer filed a Voluntary Petition for Individuals Filing for Bankruptcy (the "<u>Petition</u>") under Chapter 13 of Title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of Texas, Houston Division, in a case styled *In re Sandra Nicely, Debtor*, Case No. 24-35704 (the "<u>Bankruptcy Case</u>"). A true and correct copy of the Petition is attached hereto as <u>Exhibit A</u>. The Bankruptcy Case remains pending.

Pursuant to 11 U.S.C. § 362, the parties in this action are stayed and enjoined from taking any further action to obtain or enforce a judgment in this or any another cause of action arising before the filing of the Bankruptcy Case. Therefore, Counter-Plaintiffs request that this Court retain this action in its active docket, pending the disposition of the Bankruptcy Case.
