AGREED JUDGMENT

Zions Bancorporation N.A. d/b/a Amegy Bank's (the "Bank"), Eco Glass Recycling, LLC, Glass Partners, LLC and Steven Ragiel enter into this Agreed Judgment as follows:

It is ORDERED, ADJUDGED and DECREED that Amegy Bank have and recover of and from Glass Partners, LLC as follows:

Actual damages in the amount of \$82,892.59 as of January 6, 2024.

Interest in the amount of \$5,042.85 as of January 6, 2024, with interest accruing at the rate of \$11.08 per day through the date of judgment; It is further

ORDERED, ADJUDGED and DECREED that Amegy Bank have and recover of and from Eco Glass Recycling, LLC as follows:

Actual damages in the amount of \$792,764.04 as of January 6, 2024.

Interest in the amount of \$83,094.01 as of January 6, 2024, with interest accruing at the rate of \$188.72 per day through the date of judgment; It is further,

ORDERED, ADJUDGED and DECREED that Amegy Bank have and recover of and from Steven Ragiel as follows:

Actual damages in the amount of \$916,868.77 as of January 6, 2024.

Interest in the amount of \$90,773.80 as of January 6, 2024, with interest accruing at the rate of \$205.92 per day through the date of judgment; It is further,

ORDERED, ADJUDGED AND DECREED that Amegy Bank have and recover of and from Eco Glass Recycling, LLC, Glass Partners, LLC and Steven Ragiel, jointly and severally,

Attorneys' fees in the amount of \$25,000.00 through the trial of this matter; an additional attorneys' fee of \$25,000.00 should this matter be appealed to the court of appeals and such appeal is unsuccessful; the additional sum of \$25,000.00 is awarded to the Bank in the event that this matter is appealed to the Texas Supreme Court and appeal is unsuccessful.

IT IS FURTHER ORDERED that the judgment here rendered shall bear interest at the rate of ten percent (10%) from the date of judgment until paid.

All costs of court expended or incurred in this cause are adjudged against Eco Glass Partners, LLC, Glass Partners, LLC and Steven Ragiel.

All writs and processes for the enforcement and collection of this judgment or the costs of court may issue as necessary.

All relief not expressly granted herein is denied and this is a final appealable judgment.
