Re: Andrew Peter Lehman's Current Address

Dear Sir or Madam,

I am writing to request the current address for Mr. Andrew Peter Lehman in order that I may issue process of service in my legal proceedings.

As detailed in my accompanying letter, Mr. Lehman has violated his agreement with CFPB, which requires enforcement. See CFPB newsroom; "Consumer Financial Protection Bureau Files Suit against Certified Forensic Loan Auditors, Andrew Lehman, and Michael Carrigan, and Proposed Settlement with Carrigan" (Sep 6, 2019); "Consumer Financial Protection Bureau Announces Settlement with Foreclosure Relief Services Company and Its Owner" (Jul 23, 2020).

One of the terms of the settlement agreement is that Mr. Lehman must, at all times, provide the CFPB with his current contact information, which includes his home address. See, in part;

*“Compliance Provisions; Reporting; “Defendant CFLA or Lehman or both, as applicable, must notify the Bureau of any development that may affect compliance obligations arising under this Order, including but not limited to, the filing of any bankruptcy or insolvency proceeding by or against Defendant CFLA or Lehman; or a change in Defendant CFLA or **Lehman’s name or address.**” (emphasis added).*

I am aware Mr. Lehman is presently a litigant involved in stop eviction proceedings in Texas (Andrew P Lehman vs. Re/Max LLC, Sarah Mills, Patricia Minicom, Brian Schweiker Group Real Estate Services, Karri Riddle, Brian Schweiker, case no. 23-04-04823, Montgomery County, Texas), and it is upon information and belief that he is residing at a new undisclosed permanent address, which I seek to recover from your agency.

I am submitting a copy of this request to Mr. Lehman’s criminal defense attorney, who may be able to provide an update to either the agency and/or myself on Mr. Lehman’s current housing, tenancy, or homeless status.

Your expeditious attention to this matter is earnestly appreciated.
