- (2) Avoid injurious or vicious habits. You are forbidden to use, possess, or consume any controlled substance, dangerous drug, marijuana, alcohol or prescription drug, not specifically prescribed to you by lawful prescription. You are forbidden to use, consume, or possess alcoholic beverages.
- (3) Avoid persons or places of disreputable or harmful character, specifically:
- Report immediately in person, to the Community Supervision Officer for the 178th District Court on the (4) 3rd day of OCTOBER, 2007 and continue to report to the Community Supervision Officer on the 3rd of each month thereafter or as directed by the Community Supervision Officer for the remainder of the supervision term unless so ordered differently by the Court.

- Support your dependents as required by law. Provide your Community Supervision Officer with a (9) certified copy of all Court orders requiring payment of child support.
- (10)Submit to RANDOM drug/alcohol analysis by authorized personnel of HCCS&CD, including any department having courtesy supervision jurisdiction. Provide proof of any medication legally prescribed to you prior to submitting a specimen.
- (11)Participate in the HCCS&CD Community Service Restitution Program (CSRP). You shall perform a total of 200 hours, at the rate of 10 hours per MONTH beginning NOVEMBER 3, 2007
